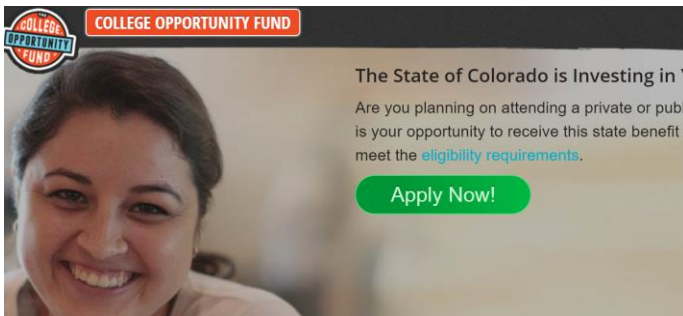


# Applying for the College Opportunity Fund

The College Opportunity Fund (COF) is the amount of money per credit hour paid by the state of Colorado on behalf of an eligible undergraduate student attending a participating college in the state of Colorado. You need to complete a short application to get this money.

Undocumented/DACA/Dreamer students can complete this application if they have attended a high school in Colorado for at least three years. If you have questions, please see a Future Center counselor.
